# Stand With Wyatt McMinn: "Drop the Charges Now!"

On September 5, Wyatt McMinn, vice president of Painters and Allied Trades (IUPAT) Local 10 in the NW Oregon/SW Washington area, was arrested and charged with first-degree trespassing. Wyatt was taking part in a labor protest at a Vancouver meeting of the Freedom Foundation, an anti-union lobbying outfit that is putting "right to work" initiatives on the ballot in Oregon and Washington this year.

Facing up to a year in prison and thousands of dollars in fines, Wyatt's trial begins in Clark County District Court on June 27. What they call "trespassing" was Wyatt exercising his right to free speech at a public meeting! Wyatt took a stand for all of us when he answered the Wal-Mart-funded lobbyists who want to take away workers' right to organize and strike. Now we must stand with him. This frame-up prosecution aims to pave the way for more attacks on working people by the billionaire bosses.
